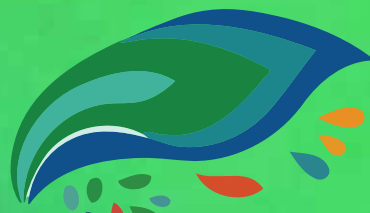

JOURNEY OF RAMPUR KRISHAK FPC- FROM HUMBLE BEGINNINGS

Rampur Krishak Farmer Producer Company (FPC) was established in July 2020 under the guidance of the district administration and the mentorship of “Padma Shri” awardee Shri Bharat Bhushan Tyagi. It started with 10 directors and a vision to empower farmers through cluster farming, diversification, mobile solar cold storage, solar cold storage chain solutions, high-value crop cultivation, local market access, marketing, branding, biodiversity promotion, technical training, and a commitment to the Vocal for Local movement.

Initially operating with just four members, the FPC built trust through its core values of **Trust, Transparency, and Togetherness (3Ts)**. Training programs and meetings were organized across villages to mobilize farmers. To strengthen the supply chain, solar-powered cold storage units were established in collaboration with farmers, including four additional solar cold stores with a combined capacity of 100 metric tons, and a 12 MT mobile solar cold store, inaugurated by the Honourable Chief Minister of Uttar Pradesh. Additionally, a 50 MT silo was constructed in 2020 to enhance storage capacity.

Field visits and conversations with farmers revealed excessive chemical usage in agriculture, resulting in nutrient-deficient food and widespread health issues. In collaboration with health and nutrition experts, Rampur Krishak FPC launched the **Aahar se Upchaar** initiative,

promoting chemical-free, nutritious crops such as Millets, Ragi, Pearl Millet, Kodo, Quinoa, Black Wheat, Mushroom, Amla, Linseed, Sesame, Moringa and Shatavri. Based on these crops, the customized Poshan Kits were formulated.

Following the initial success, the need arose to scale up production and improve logistics. With support from the district administration and financial assistance from NABARD, Rampur Krishak FPC established a production and packaging unit within the district to meet growing demand and ensure the sustainability of the initiative as well converge with ICDS, PRI, Agricultural and Education Department.

- Test is to be carried out in a peaceful/quiet area of the Anganwadi Centers (AWC).
- SAM children who fail the appetite test shall be referred to NRC.
- Children who pass the appetite test shall be enrolled as beneficiary under the Supplementary Nutrition Program and also referred to PHC Medical officer for medical assessment.

It ensures access to wholesome, culturally appropriate, and affordable nutrition, thereby supporting better health outcomes. The Poshan Kit not only focuses on immediate nutritional recovery but also encourages long-term healthy eating habits. By linking local farmers and communities, it strengthens the food system and empowers grassroots efforts in the fight against malnutrition.

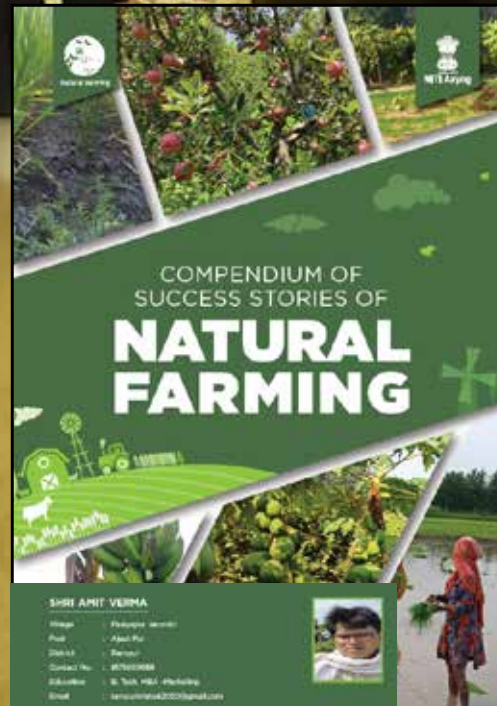

SANVARDHAN – SUPOSHIT RAMPUR: EK PEHAL

“Sanvardhan – Suposhit Rampur: Ek Pehal” was implemented through collaboration among the District Administration, Farmer Producer Organizations (FPOs), Panchayati Raj Institutions, Gram Pradhans, Anganwadi Workers, and frontline health staff like ASHAs and ANMs. Services were primarily delivered through Anganwadi Centers and FPOs.

Rampur, a district in western Uttar Pradesh with a population of about 27 lakh, faced significant child malnutrition challenges. As per NFHS-5 (2019–21), 17.6% of children under five were wasted, 5.9% severely wasted, and 32.1% underweight. Addressing these issues required a multi-faceted strategy focusing on maternal and child health, including antenatal/postnatal care, iron and folic acid supplementation, institutional deliveries,

breastfeeding, complementary feeding, immunization, and growth monitoring, with special focus on Severe Acute Malnutrition (SAM).

Beneficiaries included children above six months, high-risk pregnant women, lactating mothers, and anaemic adolescent girls. Identification used anthropometric tools and hemoglobin tests. Over 5,000 individuals were targeted for a structured three-month nutrition regimen.

The initiative emphasized systematic enrollment, field/home visits, centralized monitoring via a POSHAN War Room, and third-party evaluations. It achieved a 94% recovery rate among SAM children, improved women's health indicators, increased farmer incomes, and created local jobs—reflecting the spirit of Jan Bhagidari and sustainable development.

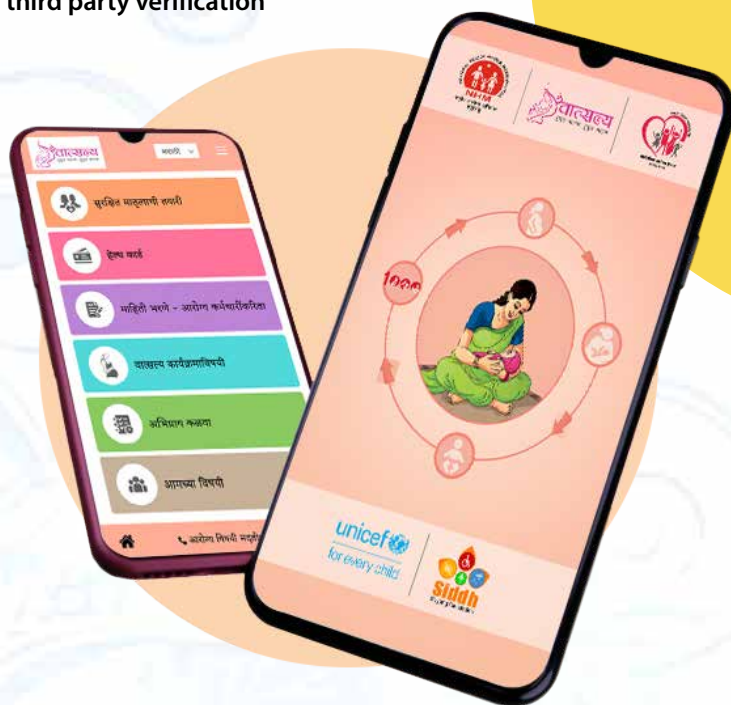

As a part of this project, Rampur and 11 district administration has undertaken significant efforts to provide quality nutrition & health services which minimised preventable child and maternal mortality & morbidity. The overall result may be summarised as under-

15000 Farmers economically strengthen Diversified Land increase from 0-788 Hect.



In year 2022, MMR reduced by **28.9%**, IMR reduced by **8.3%**, ANC increased by **29.3%**, Anaemia in age group 15-19 years reduced by **75.5%** and malnutrition (SAM) significantly reduced by **59.3%** as compared to year 2020.



Within three months, **95%** of malnourished people moved out of the SAM category By utilising poshan kits, such as shakti millet poshan kit for anaemic girls, millet poshan kit for pregnant women, amritam millet poshan kit for lactating mothers, and millet poshan kit for children.

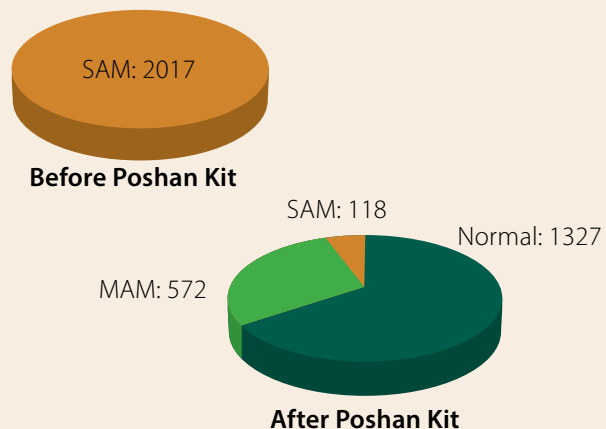

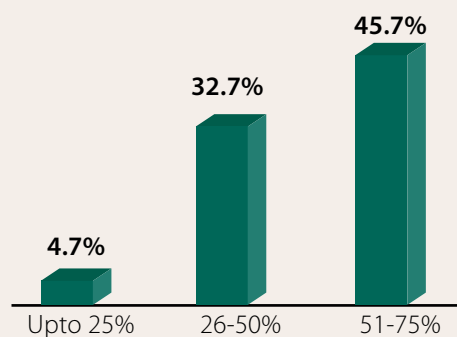
NUTRITION STATUS OF CHILDREN - PHASE-I

PERCENTAGE OF FARMERS



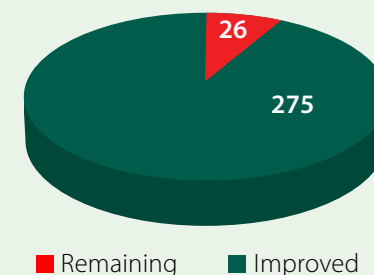

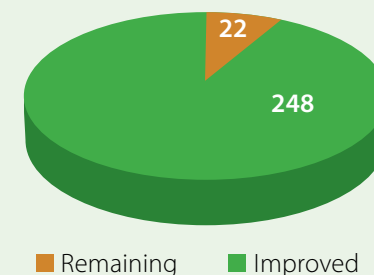

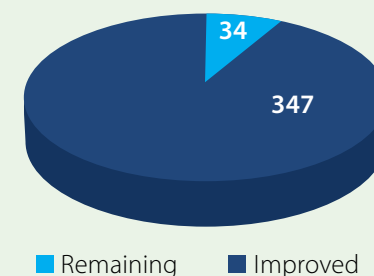

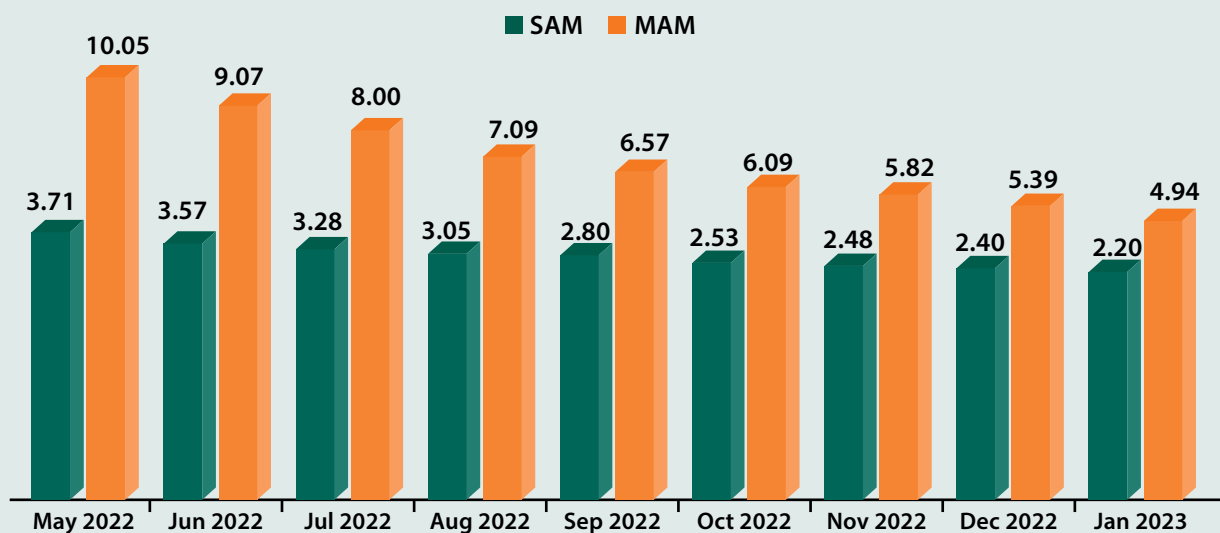

SUCCESS STORY

When height and weight of Hrithik was measured, he was identified under severe category of malnutrition (SAM). He was not regularly coming to anganwadi center. It came to notice that he was not even having home cooked food properly. The economic condition of his family is weak, his father is a rickshaw puller. There are two other children in his family. Due to lack of awareness about health and nutrition of the child, proper attention was not given to the children.

When the child was identified in the SAM category, proper counseling of the family about the nutritious food and cleanliness was done through the home visits carried out by anganwadi worker. Apart from this, nutritional kit was also provided to the child. Along with the POSHAN kit, the child was made to consume the home cooked nutritional food. After 3 months, when the weight and height of the child was measured, he was marked in normal category.

We "Rampur Krishak FPC" is a farmer producing company endeavor to form a rich end-to-end ecosystem with efficient and smooth supply chain for farmer which can provide a decent profit of margins on his produces. Right from the agriculture input supplies, cultivation, harvesting, storage, food processing and Marketing, we are working on every step.

"We are focusing sincerely on 'Agri logistics solutions' to reduce Post harvest losses as much as possible "

Rampur Krishak FPO is strived towards continuous strength improvement of the farmer in the following areas:

- ➔ Raw Inputs (fertilizer and planting material for incremental reduction in input costs)
- ➔ Farm mechanization (Cluster based farming reduces the overhead and makes the labor cost optimized)
- ➔ Post-harvest Infrastructure (setup packhouses, grain silos, Solar Cold Storages, Mobile Solar Cold Storages

CURRENT CHALLENGES OF FARMER / PRODUCER

Indian farmers incur Rs 92,651 crore per year in post-harvest losses, the primary causes of which are poor storage and transportation facilities

Market is the primary medium for farmers to exchange their produce for money, because of lack of logistics connectivity their harvest reaches late in the markets which results in lowering of the farmers' ability to monetize their produce. This becomes even more critical in case of perishable fruits and vegetables.

"At the all-India level, the proportions of the produce that farmers are unable to sell in the market are 34 per cent, 44.6 per cent, and about 40 per cent for fruits, vegetables, and fruits and vegetables combined/' finds the committee on Doubling of Farmers' Income. This means, every year, farmers lose around Rs 63,000 crore for not being able to sell their produces for which they have already made investments.



The existing cold storage capacity is confined mostly to certain crop types and not integrated with other requirements. In fact, close to only 16 per cent of the target set for creating integrated pack-houses, reefer trucks, cold storage and ripening units has been met. This means, The country is lagging in all other Agri-logistics required to bring the produce from farm to markets. If it's been plugged, the sector can create over 3 million jobs, a majority of which will be at the village level, says the State of India's Environment in Figures 2018.

OUR COLD STORAGE SOLUTION

To Strengthen the Agri-logistics, catering a Low-cost Solar Mobile/stationary cold Storage to Farmers to smoothen the Agri-Business Supply Chain which enables connectivity between farm to cold storage, farm to market, cold storage to Market. A potential ability to provide value-added services in Agri-business Supply Chain.



To Overcome the Post harvest losses and various other Pre-cooling logistics Rampur Krishak FPCL has come up with a Multipurpose Solution Mobile/Stationary Solar cold storage cum dryer which has functioning of Hydro Pump, Ripening chamber along with Mushroom Cultivation unit as well. In short can be call as a Mini Processing Unit.

We, the team of 2500 Farmers are main people behind the idea under the leadership of FPO directors mainly Rampur Krishak FPO's President Mr. Amit Verma .

A dire need of reducing of "Post harvest losses" was the main reason the get this idea take place which drives us to land up on this idea.
